Sex After The Resurrection

So let's answer this in full, carefully and accurately, using:


- Scripture (esp. Jesus' teaching in Matthew 22, Paul's resurrection discourse, Revelation 21–22)

The Greek word translated as "lust" in many English Bibles is ἐπιθυμία (epithymía), which literally means:

"Desire," "strong longing," or "earnest craving"

It is morally neutral in itself — the context determines whether it is:

- •Good (righteous, holy longing), or
- •Bad (unlawful or misdirected desire)



Examples of Positive Epithymía

1.Luke 22:15 — Jesus says:

"With fervent desire (ἐπιθυμίᾳ ἐπεθύμησα) I have desired to eat this Passover with you before I suffer."



This is a righteous, holy longing — the same word.

2.Philippians 1:23 — Paul says:

"I desire (ἐπιθυμίαν ἔχων) to depart and be with Christ..."



Again, clearly a holy desire.

So "lust" as it's used in modern English carries a negative connotation, but the Greek term does not inherently imply sin.

II. SEXUAL DESIRE IS NOT SINFUL — UNRIGHTEOUS OBJECTS OF DESIRE ARE

Here's the correct way to view it:

"The desire for sex itself is not sinful unless it is with someone God didn't want you to do it with."

That lines up with the Bible and Early Church understanding:

So yes — sexual desire for one's God-intended partner is not "lustful" in the sinful sense.


It's righteous, even sacred — and in the Eternal Age, it is fulfilled, glorified, and never shamed.

"And Adam knew Eve his wife, and she conceived..."

Some take this to mean sex only began after the Fall. However:

- •The word "knew" (yada') is used here in the sense of conception, not necessarily the first time ever.
- •Genesis 4 is after exile from Eden but does not say this was Adam's first sexual act.
- •Genesis 3 never says God forbade sex. The Fall was caused by disobedience to the Tree of Knowledge, not by intimacy.

III. EARLY JEWISH AND CHRISTIAN INTERPRETATIONS



Belief that sex in Eden was blessed and unfallen is attested:

- •Philo of Alexandria (1st c. BCE-1st c. CE): saw Edenic union as symbolic of harmony between reason and emotion, including sexuality without excess.
- •Talmud (Yebamot 62a): Rabbis debated whether Adam and Eve had children before the Fall; some believed they did.
- •Church Father John Chrysostom (4th c.): Taught that sex was intended to be holy and without shame before the Fall.

Others, like Augustine, believed reproduction was possible but would have happened without "lust," meaning without the disorder caused by fallen desires.

IV. THEOLOGICAL CLARITY: WAS SEX PART OF GOD'S **ORIGINAL DESIGN?**

- •God created bodies as male and female, not merely for reproduction but for union.
- There was no shame in nakedness.
